TERMS AND CONDITIONS

Bookings: Quotations – are subject to availability and are not guaranteed until receipt of the deposit, confirmed in writing. All care is taken when quoting, however if there is a miss-quote or an incorrect price advertised the owner reserves the right to refuse the booking or terminate the agreement. Booking Requests are subject to availability and confirmation in writing.

Usage – the premises are let to you for accommodation purposes ONLY and only for the period stated on the receipt. NO weddings, parties or large gatherings are allowed. The number of people occupying the premises must not exceed the number of people that were initially booked and/or has beds provided for.

Payment of bookings: To secure a reservation, 25% deposit of the total tariff is required at time of booking. Should your deposit not be paid by this time, the booking will be automatically cancelled. If a booking is made within a month of the booking date, the full amount is required. Balance is to be paid prior to arrival. We accept credit card (VISA MC) and direct deposit. **Please note credit card payments incur a 2% surcharge.**

Please Note: The deposit constitutes acceptance of these Terms and Conditions.

Booking sight unseen: If you book a property over the phone or via photos on the internet without viewing the property in person, we cannot be held responsible for any change to the property or misconception of the description. TERMS AND CONDITIONS (cont'd)

Smoking: No smoking is allowed inside the unit. No cigarette butts or other objects are to be thrown off the balcony, please use the ash trays provided.

Pets: Not allowed
